# A POWERFUL LESSON ON RELIABILITY

## Co-op members and elected officials tour Cardinal Power Plant

For more than 87 years, Firelands Electric Cooperative's mission has been to deliver reliable, environmentally responsible electricity to our member-owners and the communities we serve — and to do so at affordable rates. A key component of our efforts to achieve this goal is the Cardinal Power Plant, which provides electricity to 400,000 co-op homes, farms, and businesses throughout Ohio, including 9,200 in Firelands' service territory.

On Sept. 13, during our annual tour of Cardinal, the cooperative was able to provide a very powerful lesson on the importance of this generation facility and the issues that threaten to put it and the nation's electric industry at risk.

Outfitted with more than \$1.2 billion in environmental control equipment, Cardinal is a standout among power plants. The expert operators at Cardinal continue to make improvements to the fuel mix and other environmental

controls, decreasing emissions by 20% in just the past decade. In fact, Cardinal's environmental standards have long been higher than those of the EPA, making it one of the cleanest coal-fired power plants in the world.

For decades, Cardinal has also sold fly ash (a waste product from burning pulverized coal) to companies who repurpose it for use in cement, concrete, and other construction materials. With an ever-increasing demand for this by-product, a recent agreement with Separation Technologies LLC will practically eliminate Cardinal's need to dispose of fly ash in a landfill — further reducing any possible negative impact.

Unfortunately, this dependable energy source is being challenged by the proposal of poorly designed national energy policies and proposed new regulations. Despite Cardinal Power's long history of environmental consciousness, the regulations that are on the table put the plant's future, and its reliable and affordable supply of electricity, in jeopardy. Ohio's electric cooperatives, including Firelands, have even been directed to put a plan in place for potential rolling blackouts.

The electric industry is not standing idly by, however. Organizations such as the National Rural Electric Cooperative Association ([electric.coop](http://electric.coop)), the Federal Energy Regulatory Commission ([ferc.gov](http://ferc.gov)), and PJM Interconnection ([pjm.com](http://pjm.com)) have all been voicing their concerns to policymakers. While efforts to reduce the impact on our environment are crucial, they must be balanced with reality. The practicality of implementing mandated, untested technology and infrastructure by 2030 (the deadline proposed by these new regulations) is simply unattainable.

While electric industry representatives are doing their part in our nation's capital, Firelands is working to educate our members, communities, and legislators about the potential effects of these ill-conceived





## KEN KEENER RETIRES

Ken Keener has witnessed a lot of changes since he joined Firelands Electric in 2007. As the cooperative's meter technician, his primary duties have included maintaining the metering system and locating underground lines.

In the early part of his career, Ken was responsible for the manual adjustment and testing of meters, as well as connecting and disconnecting service to members' homes and businesses. In 2014, however, the co-op upgraded to an advanced metering system with two-way

automatic communications, causing Ken's duties to evolve. In more recent years, he has spent more of his time performing meter exchanges and programming meters, as well as helping troubleshoot the occasional communication issue with the co-op's software.

Another large part of Ken's typical workday involves underground line locating. When co-op members need to have their power lines located and marked for an upcoming project on their property, they contact Ohio Utilities Protection Services (OUPS). Ken then visits the site and uses a device with ground penetrating radar (GPR) technology to detect the flow of electricity beneath the surface. These lines are then marked so that the member can complete their project safely.

After more than 16 years of serving Firelands Electric members, Ken retired in early October. Although he will miss helping the co-op's members, he's also looking forward to retirement. "I plan to spend more time working on our farm and with our children and grandchildren," Ken says. He and his wife, Beth, live in the Ashland area and have three sons, eight grandchildren, and one grandchild on the way.

# SALUTING OUR VETERANS



District 2 Trustee Gene Lamoreaux was a member of the U.S. Army from 1967 to 1970. During this period, he spent two years training in Germany. Achieving the rank of Specialist Fifth Class, Gene served as a Hawk missile electronics technician.



Journeyman Lineman Chris Kent was a member of the U.S. Army National Guard from 2005 to 2018. After three years serving in the military police, he was selected to be a small arms marksmanship instructor for Ohio. Chris was deployed to the Middle East as part of Operation Enduring Freedom in 2012 and finished his military career having achieved the rank of Sergeant.

Since the American Civil War, more than 41 million men and women have served in the U.S. Armed Forces. Of these soldiers, more than 1.3 million lost their lives during combat. While Memorial Day dates back to shortly after the end of the Civil War (1868), a day to recognize ALL military veterans did not come about until the mid-twentieth century.

First organized by Raymond Weeks in Birmingham, Alabama, in 1947, Veterans Day became a national holiday in 1954. Today, all Americans who served their country are recognized on Nov. 11 for their contributions.

# BOARD MEETING *highlights*

*Firelands Electric Cooperative's Board of Trustees met Aug. 22 and covered the following items:*

- Board President Dan Schloemer reported that the cooperative received 25 membership applications for approval by the board.
- General Manager Dan McNaull reviewed the cooperative's 2023 Power Requirements Study, which projects a 0.7% increase per year over the next ten years.
- OEC's Missy Kidwell presented detailed results of the cooperative's 2023 ACSI scores. She explained that the overall satisfaction score improved by one point from last year, giving Firelands a rating of 88. She also noted that the co-op scored the highest in the categories of "Friendly" and "Highly Trained and Professional."
- McNaull summarized the tree-trimming and outage reports for the past month.
- The board was reminded of the Cardinal Power Plant Tour on Sept. 13 and the 2024 NRECA Power Xchange in March.
- Director of Finance and Accounting Tabi Shepherd reviewed the July financial reports and provided an update on recent accounting and billing department activities, including the positive results of a recent audit.
- The board reviewed a report from a safety and training event held on July 26.
- McNaull recapped the OEC Summer Conference, which was held in August.
- In the absence of Director of Communications and Technology Andrea Gravenhorst, McNaull reported on recent activities involving the member services and IT departments.
- Director of Operations Don Englet reported on activities in the operations department.
- McNaull reported on a recent Buckeye Board meeting.
