## TERMS AND CONDITIONS

**Effective Program Dates: July 1, 2024 through June 15, 2025**

### • \$100 REFRIGERATOR & FREEZER REBATE\*

ENERGY STAR®-certified refrigerators and stand-alone freezers (10-30 cubic feet) can qualify for a \$100 rebate from Firelands Electric Cooperative, as long as the old appliance is disposed of and the new appliance is installed at a location served by the cooperative.

### • \$50 DISHWASHER, CLOTHES WASHER & CLOTHES DRYER REBATE\*

ENERGY STAR-certified electric dishwashers, clothes washers, and dryers can qualify for a \$50 rebate from Firelands Electric Cooperative, as long as the old appliance is disposed of and the new appliance is installed at a location served by the cooperative.

### • \$25 DEHUMIDIFIER REBATE\*

ENERGY STAR-certified dehumidifiers can qualify for a \$25 rebate from Firelands Electric Cooperative if it has a minimum capacity of 50 pints/day and the new appliance is installed at a location served by the cooperative. (Proof of removal is NOT required for dehumidifiers.)

• Member is required to provide a copy of the purchase receipt, showing that the new appliance was installed in a home or facility served by the cooperative. Member must also include proof of ENERGY STAR-certification, such as a copy of the owner's manual or other documentation containing the ENERGY STAR logo or a statement of ENERGY STAR-certification. Documentation showing that the old appliance was removed/recycled from the home or facility is also required to be eligible for the rebate (NOT required for dehumidifiers).

• All rebates are issued in the form of a credit to the member's electric account.

• Rebates may not exceed the purchase price. Appliances must have been purchased and installed in the past 12 months.

• If you pay less for your appliance than the rebate amount, you will receive the amount you paid.

• A maximum of six appliance rebates, totaling \$375, may be paid per home/facility per current program year.

**\*Firelands' appliance rebate budget is limited. Offer expires when funds are depleted on a first come, first served basis, or when the program is discontinued.**

## Appliance Rebate

### Additional Information

To qualify for an appliance rebate, applications **MUST** include documentation that the new appliance is ENERGY STAR®-certified. Documentation may be provided by mail, email, or fax, and photocopies are encouraged.

Acceptable documentation for ENERGY STAR certification include one of the following:

- \* a yellow Energy Guide Label with the ENERGY STAR® logo in the lower right corner
- \* an owners manual with the ENERGY STAR logo
- \* an appliance specification sheet stating that the unit is ENERGY STAR-certified

Please note that yellow Energy Guide Labels without the ENERGY STAR logo do not qualify. See below for an example of an Energy Guide Label that includes the information required for the rebate.

U.S. Government Federal law prohibits removal of this label before consumer purchase.
