**INTERRUPTABLE ELECTRIC GRAIN DRYING  
SCHEDULE GD**

**AVAILABILITY AND APPLICABILITY:**

This schedule is available throughout the Cooperative's entire service area subject to the established Rules and Regulations of the Cooperative and the following stipulations:

Applicable to single or three-phase electric grain drying installations with service through a single set of wires and separately metered. This special rate applies only to low-temperature, natural air grain drying bins, which use electricity as the sole energy source. No natural gas, propane or other type of fossil fuel grain drying heater shall be used with the installation at any time.

This rate is available only to electric grain drying accounts using 10,000 or more kWh per year. Accounts using less than 10,000 kWh per year will be billed on the applicable Single-Phase General Service or Small Three-Phase rate schedules.

**TYPE OF SERVICE:**

Single or Three-phase, 60 hertz, at available secondary 120/240 or 120/208, 277/480 nominal voltages.

**NET RATE PER MONTH:**

Distribution Charge:

Single-Phase	\$53.65/month
Three-Phase	\$110.30/month

Energy Charge:

All kWh	\$0.0945 /kWh

**MONTHLY MINIMUM CHARGE:**

The monthly minimum charge under this schedule shall be the Distribution Charge, or such other minimum as may be established by contract.

Seasonal disconnects will not avoid the monthly minimum charge.

**WHOLESALE POWER AND TAX COST ADJUSTMENT:**

The rates and charges set forth in this schedule are subject to increase or decrease by application of the adjustments specified in Rider A.

## **INTERRUPTABLE ELECTRIC GRAIN DRYING**

### **TERMS OF PAYMENT:**

The above rates and other applicable charges hereinafter set forth are net and are due and payable on or before the date specified on the bill. If not so paid, the gross amount applies and service will be subject to disconnection as provided in the Cooperative's rules and regulations. Collection of past due amounts and reconnection of service shall be subject to the Cooperative's charges for such special services.

### **METER READINGS:**

Meters are read monthly using an automated meter reading system (AMR). However, the Cooperative reserves the right to read any meter at any time, or use an estimated meter reading.

### **USE OF SERVICE:**

Service under this schedule shall not be resold or shared with others.

This special rate is contingent on the member interrupting or disconnecting use when requested during periods of Peak Demand. Failure to remove service during a period of Peak Demand or the use of supplemental fossil fuel heaters revokes the use of this special rate, and all electricity used during that calendar year will be billed at the applicable standard rate as determined by the Cooperative.

### **OTHER CHARGES FOR SPECIAL SERVICES:**

See the Cooperative's general rules and regulations as to other applicable charges.
