**OUTDOOR LIGHTING SCHEDULE  
SCHEDULE L**

**AVAILABILITY AND APPLICABILITY:** This schedule is available throughout the Cooperative's entire service area subject to the established Rules and Regulations of the Cooperative, and subject to a location where the lighting fixture and pole(s) can be installed.

Outdoor lighting service is available only where there is reasonable assurance that the lighting service to be furnished will be on a permanent, continuous 12-month basis. The Cooperative reserves the right to refuse lighting service under this schedule where the installation, in the Cooperative's opinion, will not be permanent.

Where the premises are occupied by a tenant, the Cooperative reserves the right to require the application for service to be made by the property owner. Billing will be sent the tenant however; the property owner shall be ultimately responsible for the payment. Both tenant and property owner are responsible for any special service charges, which can be found in the Cooperative's Policy Bulletin 8-8.

**CHARACTER AND TYPE OF SERVICE:** The Cooperative will install, own, operate and maintain at its expense the lighting fixture and related appurtenances. The lighting fixture shall be photoelectric or otherwise controlled so as to provide substantially dusk to dawn year around lighting service. It is the member's responsibility to contact Firelands Electric Cooperative if the fixture is not working properly.

Lighting fixtures will be installed only on the Cooperative's poles. All material used to install outdoor lighting shall remain the property of the Cooperative.

The Cooperative will install one pole and one span of secondary wire of up to 150 feet in length per light fixture. The monthly base rate includes the fixture, pole, wiring, maintenance and electricity. If additional poles are required, the monthly rental charge will be increased \$4.00 for each additional pole constructed.

**Outdoor Lighting Schedule**

**MINIMUM CHARGE:** This lighting service is furnished only on a permanent, continuous 12-month basis. One-twelfth of the total annual charge for each fixture, and extra pole(s) if required, is payable monthly, and disconnection of service will not avoid the applicable total annual charge.

**ADVANCE PAYMENT OF ANNUAL CHARGE:** When determined by the Cooperative that a member's regular service is seasonal or non-permanent in character, the Cooperative reserves the right to require 12 months advance payment before service is established and thereafter to require similar advance payments prior to the commencement of each succeeding 12 months of service.

**PAYMENT AND BILLING:** The monthly rental charge for lighting fixture(s), and extra pole(s) if required, will be set forth as a separate item on the member's bill. The lighting charge is payable in the same manner as the bill for metered electric service and shall be subject to penalties for late payment and disconnection for non-payment.
