According to *Forbes* magazine, less than 25% of people who make New Year's resolutions stick with them for more than a month, and only 8% are successful at accomplishing them. SmartHub

One of the most convenient tools Firelands Electric has available for co-op members is SmartHub. The app, which many already use to pay their monthly electric bill, is also a tool for monitoring your energy consumption. Featuring state-of-the-art technology, SmartHub allows members to examine their electric use by the month, day, or even hour.

Members can determine their average electric use, compare current and previous months, or utilize the Plan and Save feature to track changes resulting from the installation or removal of items such as a space heater, swimming pool, extra refrigerator, or large appliance. Members who sign up for the Power Usage Alert can even get notices sent to their email or phone when they use a certain amount of power over a specific time period, based on parameters they choose within the app. Having this kind of information at your fingertips can help pinpoint when and where you use the most power, so you can make adjustments accordingly.

Your solar partner

For some, being more energy efficient means going green. With increased availability and affordability, the interest in residential solar panels continues to climb. The ever-changing technology and abundance of information out there can be overwhelming. Determining the best option for your particular situation can be difficult, but Firelands Electric's energy advisors are here to assist. NESTING POLE INSTALLATION

CLEARED FOR LANDING



In November, Director of Operations Don Englet, Line Superintendent Zach Collins, and Journeyman Lineman Rick Bowers helped Pleasant Hill Lake Park install a 65-foot pole for eagle nesting. A 6-foot-square platform, which can support about 3,600 pounds, sits atop the pole and will provide a safe space for eagles in the area to nest.

The new pole joins five osprey nesting platforms already at the Perrysville-area park. Firelands Electric was involved with installing four of these five existing platforms.

The project also gave Firelands' linemen a chance to test out the co-op's new tracked derrick-digger. Designed to access the roughest terrain, the derrick-digger was the perfect piece of equipment for the nesting platform installation. "This new machine will give the cooperative accessibility to areas that are either too wet or too steeply sloped for trucks to reach," Firelands Electric General Manager Dan McNaul says. "It will also allow crews to do more line work from the field side of ditches, resulting in fewer instances where trucks will need to be parked on the roadway."

- Applicants will be judged on scholastic record, school and community activities, cooperative knowledge, and a personal interview.

COOPERATIVE UPDATE

BOARD MEETING *highlights*

Firelands Electric Cooperative's board of trustees met Oct. 27 and covered the following items:

- Board President Dan Schloemer reported that the cooperative received 48 membership applications for approval by the board.
- Director of Finance and Accounting Tabi Shepherd reviewed the September financials and reported on recent accounting and billing department activities.
- The board reviewed and approved a report from a safety meeting held Oct. 16.
- General Manager Dan McNaull presented the proposed capital budget for 2021, which was approved following discussion.
- Director of Operations Don Englet reviewed recent activities and projects in the operations department.
- McNaull reviewed the outage report for September and the status of the current tree trimming program.
- Via telephone, Brian Stavish of CFC reviewed the co-op's Key Ratio Trend Analysis for the previous year.
- McNaull reviewed a report on vehicle-related outages from 2015 through 2020.
- Director of Communications and Technology Andrea Gravenhorst reviewed a report on recent activities involving the member services and IT departments.
- McNaull asked the board to approve three appointments to the cooperative's People Fund board for 2021. District 2 Trustee Gene Lamoreaux nominated Gary Hunter, District 7 Trustee Rob Turk nominated Steve Aron, and District 9 Trustee John Martin nominated Mary Jo Paramore. The appointments of all three were approved.
- The board reviewed the recent virtual NRECA regional meeting.
