Upon acceptance of Member's application by Firelands Electric Cooperative, Inc., the Cooperative will install, operate and maintain on Member's property, one or more of the Cooperative's outdoor lighting fixture(s) and related appurtenances as specified herein.

Member shall pay the Cooperative a monthly charge, which shall include all charges for Member's rental of the lighting fixture and appurtenances, for maintenance of the fixture and appurtenances by the Cooperative, and for all electricity used in the operation of the lighting fixture.

The lighting fixture will be installed only on poles owned by the Cooperative; the lighting fixtures and all materials used in their installation are, and at all times shall remain, the property of the Cooperative. The Cooperative will install one pole and one span of secondary wire of up to 150 ft. in length for each lighting fixture. If additional poles are required, the monthly rate will be increased by \$4.00 for each additional pole and span of wire. If a Member chooses to purchase their own light fixture, the device CANNOT be installed on a pole owned by the Cooperative.

If the premises are occupied by a non-owner, the application shall be made by and in the name of the property owner. Billing may be sent to the non-owner, but the property owner shall remain responsible for the payment of the monthly charge.

Outdoor lighting service is initially available only on a one year (twelve month) basis. If during the initial year service is disconnected for any reason, Member will nevertheless be responsible for the monthly charge for the remainder of the initial year. After the initial year of service, lighting service shall be provided on a month to month basis. The Cooperative reserves the right to require a twelve month advance payment prior to the establishment of any service. Member's monthly charge will appear as a separate item on Member's monthly electric bill.

Member agrees to permit the removal of the complete lighting fixture installation at any time in the event of Member's failure to pay the monthly charge or Member's misuse of the fixture or appurtenances. Member further agrees: (1) to furnish a location agreeable to both Member and the Cooperative for installation of the fixture and appurtenances; (2) to complete initial tree trimming/clearing required for installation, and to permit future tree trimming to maintain proper light fixture and wire clearances; and, (3) to execute any easement which the Cooperative deems necessary to install and maintain the lighting fixture and appurtenances.
