

Bordas has also taken the local co-op message to congressional representatives during her annual visits to Washington, D.C.

"It's all of the employees being one team that works hard to get the job done, day or night, rain or shine. YOUTH PROGRAMS



America's electric co-ops believe in educating tomorrow's leaders. Since the late 1950s, the Electric Cooperative Youth Tour has brought high school students to Washington, D.C., to experience our nation's capital up close. Through educational and sightseeing activities, students gain a personal understanding of American history and their role as a citizen.

About 40 students from electric cooperatives throughout Ohio participate in this COMPLETELY FREE program each year. Students meet at Ohio's Electric Cooperatives in Columbus, and travel by chartered bus to Washington, D.C. Chaperones from the community, including parents, teachers, and electric co-op employees, accompany students on this weeklong trip.

Groups are organized at the state level, but over 1,600 students from across the country come together for Youth Day. Students have the chance to meet their U.S. representatives and senators, as well as hear featured speakers who provide insight into the important roles electric cooperatives play in their local communities.

also have the opportunity to be selected as their state's representative on the National Rural Electric Cooperative Association's (NRECA) Youth Leadership Council (YLC). One student from each state is selected to return to Washington, D.C., in July for a leadership workshop that focuses on the electric cooperative industry. YLC members are also invited to attend NRECA's Annual Meeting the following spring.

Firelands Electric will select up to two high school sophomores and juniors to represent the co-op on the 2018 Youth Tour, scheduled for June 8-14.

- Poster/ad entries should be submitted in high-resolution PDF format. Videos can be live action or animated and should be submitted in MP4 or QuickTime Movie format.
- Entries must be smaller than 20 MB and should be e-mailed to members@firelandsec.com.



- Never touch a fallen power line, and assume all wires are electrically charged. Contact Firelands Electric Co-op at 1-800-533-8658 to report it immediately. Avoid contact with overhead lines during cleanup and other activities.
- ★ In the event of an outage, an alternate heating source such as a fireplace, propane space heater, or wood stove may be used, but treat any of those with caution, and make sure spaces are properly ventilated to avoid deadly carbon monoxide buildup.
- * Make sure carbon monoxide detectors and smoke detectors are working properly. Testing each once a month by pressing the TEST button is the safest bet.
- ❖ Do not use a gas-powered oven for heating because it might go out or burn inefficiently, leading to carbon monoxide poisoning.
- Do not use a gas or charcoal grill inside the home, and do not use charcoal briquettes in the fireplace.
- If you use a portable generator to power a heating source, be sure the generator is located outside your house in an open area that's sheltered from precipitation and moisture. Never use a generator in an attached garage it's still too close and could lead to carbon monoxide poisoning. Follow manufacturer's directions for operation of the unit.
- * Take special care not to overload a generator. Use appropriately sized extension cords to carry the electric load. Make sure the cords have a grounded, three-pronged plug and are in good condition.

Never connect generators to power lines. The reverse flow of electricity can electrocute an unsuspecting utility worker.

Ideally, your family will stay warm until the power comes back on. But keep an eye on family members for signs of hypothermia, which include shivering, drowsiness, and mental and physical slowness. The elderly and young children are particularly vulnerable to hypothermia. Call 911 immediately if you notice these symptoms. Try to have at least one mobile phone in the house that does not depend on electricity.



Communicating and ductless HVAC systems, as well as solar, heat pump, on-demand, and tankless water heaters, do not qualify.






BUDGET-FRIENDLY EFFICIENCY TIPS

Lighting:

LED bulbs save 60 percent or more energy than incandescent bulbs and can now be purchased at box retailers for \$5 or less.



Heating and Cooling:

Replace air filters every one to three months and seal/insulate ductwork to maximize the efficiency of your home's heating and cooling system.



Appliances & Electronics:

Keep appliances and electronics free from lint and dust, and use a power strip to turn off electronics when not in use, avoiding "energy vampires."

The cooperative's board of trustees appointed Dan McNaull as general manager of the not-for-profit organization, which will be effective upon the Feb. 2 retirement of incumbent April Bordas.

Dan McNaull has represented the members of Firelands Electric Cooperative as the trustee for District 7 for over 26 years, serving as president of the board since 1999. The co-owner and vice president of Ashland Implement, Dan attended The Ohio State University and North Central Technical College. He has also received his Credentialed Cooperative Director certification from the National Rural Electrical Cooperative Association.

Further, McNaull was the nominating committee chairman of the Ohio Rural Electric Cooperatives (OREC) board of directors, where he served numerous years on the marketing committee.

McNaull was on the joint policy committee for Buckeye Power and OREC, and served as a national parts advisory board member for Case International.

"Dan's tenure on the Firelands board, combined with his unparalleled business expertise and operational insight, make him exceptionally qualified to assume effective responsibility of our co-op," says April Bordas. "I fully endorse the board's selection of Dan, with the confidence that our members, staff, and community partners are in capable hands."

McNaull's numerous civic and volunteer activities include acting as a deacon at Ashland Dickey Church of the Brethren and serving in various capacities around his community: chairman of the Ashland Dickey Cemetery Association, chairman of the Montgomery Township zoning commission, member of Ashland County Farm Bureau, member of Ashland County Yesteryear Machinery Club, director and present board chairman for Farmers State Bank, and member of Ashland Young Men's Business Club.

Firelands Electric's board of trustees underwent an extensive search for the next general manager, considering candidates from both inside and outside the cooperative world. "Following the interview process, there was no question that Dan McNaull is the most qualified in terms of business expertise, communication skills, and leadership experience," says District 1 Trustee Dan Schloemer.



McNaull and his wife, Debbie, live near Ashland and have two grown daughters, Christy and Kelly, and a grandson. In addition to spending time with family and friends, Dan enjoys fishing and bicycling. His hobbies include caring for his family's 1815 McNaull homestead farm, doing yard work, and gardening.

"I am truly honored and excited to have been selected by the board to be the next general manager of Firelands Electric Cooperative," McNaull says. "I look forward to joining a great team of employees, as we continue to provide members with outstanding service and reliability every day.
